R. Coffey and parcell of land known as the L. E. R. Young farm, containing one hundred and eighty acres more or less, together with all the rights and privileges hereunto belonging in fee simple And the said Youngs of the first part their heirs executors, quardians and administrators the titles to the [?] aforesaid will forever warrant and defend to the said T McGhee his heirs and assigns against the lawful claims of all such? persons In witness whereof the said Youngs of the first part hereunto set their hand and seal this 31st day of December 1883
