
I have been trying to locate any information on my grandfather, ELMER CURRY STOY, and the local Washington, D. C. Marine offices have forwarded me to your office for help.

According to old pictures in the family my grandfather is shown in Marine outfits and the date on one is 1899 at age 15. Others show him in uniform in his early 20's. Family records show his date of birth at about July, 1884.

He was married April 28, 1903, to Maria Mount Caylor at Herndon, Virginia (Fairfax County). His first child was born December 21, 1904 and was named Elmer Dutton Stoy (this uncle tells me his middle name came from his father's Marine Captain, R. M. Dutton). His second child, a daughter, was born 1906 and his last child, a son, was born in 1909. His last known address was McLean, Virginia, in about 1912, however he was seen in the District of Columbia in the early 1930's. One distant relative thought he lived in Richmond, Virginia, for a while and perhaps remarried.



In reply thereto, you are informed that the records of this office show that you are not entitled to the campaign medal referred to, inasmuch as your service does not come within the purview of the regulations governing the award of said medal. The Spanish Campaign Badge is awarded to all Marines in the Navy or on shore in the Philippines or in the Island of Cuba and Porto Rico, between May 1st, 1898 and August 16, 1898. The records show that at this time, you were stationed at Marine Barracks, Washington, D. C.


