

**MONROE COUNTY, OHIO - DEED RECORDS 1814-1839**

In the court house fire of 1840, the deed books which covered the period from the organization of the county to the date of the fire were badly burned around the edges. The remaining portion of these deeds were transcribed in 1858 into what is now known as Deed Book C (Burned Records). In many instances, a good portion of the right or left side, the top or bottom of the deeds was burned. Thus, there will be more blank spaces in these records than would be usual under normal circumstances. Because the information given here is intended as a finding aid and also due to the condition of the deeds, the land descriptions have not been included. The page on which the record may be found in Deed Book C, is given in parenthesis.
