The object of the compilation of this book was for the purpose of presenting to the public much information heretofore unavailable.

While examining the New Jersey records (seeking for an ancestor), the writer found them inadequate to give her the data desired. During the progress of this search, she inadvertently learned of some hitherto unpublished records; and these, together with some already familiar chronicles, here placed for convenience, were deemed of sufficient value to justify their compilation.

The early records of the First Presbyterian Church, having been destroyed (or lost) when the parsonage and church were burned by the British the 25th of February, 1779, and 25th of January, 1780, would have afforded unlimited opportunity for researchers. Fortunately, at least one book was preserved--the sextons' burial records entitled, "Deaths of E. Town - 1766"--, to which has been added the list of burials of more recent date, making a complete sextons' burial record from 1766 to 1916; and imparted by Bertha Baldwin Bigelow, the editor, member The Genealogical Society of Pennsylvania, who carefully copied them from the original records. The early record is still in a good state of preservation.

The page numbers in the present volume correspond with those in the original record, including the bracketed numbers appearing at the foot of some pages. The record commences on page 8 and in several places blank pages occur where no entries of burial are made, and where there are evidently omissions in the record, as shown by the intervals between the dates. For instance, from 13th February, 1807, to 30th May, 1809, there are no burials recorded and several pages are here left blank, indicating that the death records of this period were probably kept in another book. Neither are there any records on pages 244 and 245, but these pages may have been turned by mistake, as dates continue consecutively from pages 243 to 246. Furthermore, the spaces left blank under age, year and disease were not filled in.

When the chapel on the Northeast corner of the First Presbyterian Church grounds was being demolished during the month of February, 1916, a book of pew holders was found beneath its floor, the contents of which is embodied in this chronicle; together with much early data (found among the effects of an aged gentleman who recently passed away), consisting of names of early Ministers, Ruling Elders, Deacons, Trustees and a long list of Communicant Members dating from 1770 to 1825; and not only giving the names of early inhabitants, but also names of members of their respective families in many instances.

A partial list is here given of the early estate holders of Elizabeth Town, as taken from the map of Ernest L. Meyers, Surveyor. Also a list of Associates and Freeholders of Elizabeth, taken from the East Jersey records which will greatly aid researchers.

To the many friends who have generously contributed material for this volume, the editor's thanks are due.

The most authentic record of the names of the original Associates of Elizabeth Town will be found in the town record, Book B., pp. 2-3, probably compiled some fifty years after the settlement of Elizabeth. It reads as follows:-

"Richard Nicoll, by virtue of the power and Authority vested in him by James (then) Duke of York &c. Did thereby Grant Bargain Sell and Confirm unto Capt. John Baker (then) of New York, John Ogden (then) of North Hampton, and John Baily & Luke Watson. (equally seized each to a THIRD LOT RIGHT in the pmisses) were, the said John Baker, John Ogden, Jn^d Baily, and Luke Watson, and with them

The total number of lot holders is eighty. Thirty-three had first lot rights, twenty-six second lot rights and twenty-one third lot rights. Baily sold his third lot right to Carteret. Previous to taking the Oath of Allegiance in February 1665-6 twenty-six had been admitted to associateship. Many were sons of the first settlers.

Of the eighteen male servants brought over in the ship Philip by Carteret, belonging to himself and Sir George, many were Frenchmen and thought to be from the Isle of Jersey:

Smith Baldwin (as above), b. 8 Oct. 1787, at Westfield, N.J., d. 27 Aug. 1823, of yellow fever. He married 15 Dec. 1807, Mary Parcell Stiles (daughter of _____ who lived near Basking Ridge, N.J.). He lived and died in Elizabeth, and was interred in First Presbyt. Churchyard of E. Town, N. J. Family tradition says he was a cousin or near relation of Matthias W. Baldwin (above, V).

Joseph Henry Baldwin m. second, Mary Eleanor Hughes, a widow of Phila., ~~a widow~~ whose daughter married his son John. Joseph's second marriage occurred Oct. 6, 1885. No issue.

He had a daughter by the first wife, Mary A. Schnaidt, named May Baldwin, who married Frederick Stout, an Englishman, about 1902, in Phila. No issue of their own. They adopted a child, Bertha, when only a few weeks old. In 1916 she is ten years old.

Lived in Florida, but later removed to Hamilton, O., and thence to Mansfield, O. where she died. Issue, one son, William Baldwin Trisler, b. 16 April, 1880. His first m. to Ethel I. Davis, Mar. 12, 1902. Divorced. Second m. was to his cousin, Elsie, daughter of Henry Baldwin. (He John Smith Baldwin, son of Joseph H. (as above.) Their children are Roy and Eleanor Alameda Trisler b. 1911.

(VIII) William Roper Baldwin, b. June 13, 1849, d. about 1904. By his marriage Mar. 1, 1875, to Phebe V. - (IX) Caleb Smith Baldwin, b. 25 August, 1851, d. July 8, 1894, of lumbago, in Cincinnati, O. Interment, Spring Grove Cemetery. He married Margaret Campbell, by whom he had one son, Frank H., b. about 1877, who was married to Margaret _____, and is a resident of Bakersfield, Cal. Caleb's widow married (second) Daniel Wise, a missionary, who died about 1913, and her third marriage took place in Pasadena, Cal., to Nelson Morris. They removed to Hutchinson, Kansas, 1916.
- (X) Eliza Ann Baldwin, b. 15 Dec. 1854, she (first) married Michael Edward Given of Cincinnati, and after his death she married secondly ~~John Alexander~~ and lived in Kansas. (Alexander) The next marriage was to John Kerble, a shoe merchant. No issue from any marriage.

(Note)

Stephen Stiles Baldwin, M.D.³ (William S.², Smith¹) b. Dec. 10, 1839, in Cincinnati, Ohio. He was twice married, first to Clarissa Ann Jones of Kentucky, by whom he had two sons, she died. His second marriage took place in Philadelphia, July 1, 1856, to Amanda Cordelia Nixon, b. Aug. 27, 1847 (daughter of Columbus Henry and Emeline M. (Supplee) Nixon) of Phila., Pa. The subject of this paragraph was an artist, but after having served four years in the Civil War he was so disabled that he was unfitted for his art. About 1872-5 he removed to the state of Nebraska (Lawson, County, and later to York.). Again removing east to Cincinnati, he studied medicine. He was a member of the Free and Accepted Masons, Cynthia Lodge, No. 5; member of the G. A. R., having served under Capt. Libe in the Civil War in Company M. 5th U. S. Cav. His first enlistment was in Cincinnati, where he had been given charge of teams. Having been twice injured by his horse being shot under him, he was sent to Satterlee Hospital in West Philadelphia, Pa. The children of the second marriage were:

"John Ogden, the ancestor of the family in this state, (N.J.) was one of the original patentees of Elizabethtown, and was an influential and popular citizen. He resided at Stamford, Conn. in 1641 within a year after its settlement, in 1644 he removed to Hempstead, L. I. of which he was one of the patentees. He was made a freeman at Southampton, March 31, 1650, and was chosen by the general court at Hartford, Conn. one of the magistrates of the colony in 1656, 1657 and 1658.

Later he became one of the original associates of Elizabethtown and, with his five sons, was one of the first to remove to the new purchase and erect a dwelling on the town plot. Timothy Ogden operated a tanyard during Revolutionary times on what is now Elizabeth Ave. His son, Moses, was a tailor, he was born February 6, 1774 and on December 6, 1797, married Rhoda Halsey, he died June 9, 1847. His son, John Ogden, was born at the family residence on Elizabeth Ave. September 11, 1799 and had nine children. In early life he became apprenticed to Colonel Elihu Brittin to learn cabinet making and continued to follow this occupation and that of undertaking during his lifetime. He was an earnest and industrious man and a zealous and faithful member of the First Presbyterian Church, he died in 1876, aged 77 years. His ancestors were in the army of Washington. He married Joanna H., daughter of Aaron Ross.

James Crawford, the only surviving member of his father's family, and who succeeded his father in the undertaking business, passed away March 24th, 1916. He was one of the oldest and most honored members of the First Presbyterian Church and was for over twenty-five years president of the Board of Trustees. Mr. Ogden's widow, Mrs. Jennie Fischer Ogden, two sons, Frank C. Ogden and Harold Ogden, and one daughter, Dorothy Ogden, survive him. Mr. Ogden was 84 years of age at the time of his decease.

PASSSELL.

I am much indebted to the person contributing the genealogy of the Passell (Pearsall) family, found on page 1219 in the Biographical and Genealogical Records of the State of New Jersey, as it coincides with my family tradition.

I--Henry Pearsall, the founder of the family, an early emigrant to Hempstead, Long Island, died 24 July, 1667, leaving five children--Nathaniel, Thomas, William, Nicolas and Daniel.

II--William Parcell, (as he spelled his name in his will), was the son of Henry Pearsall of Hempstead. He died in Newton, L.I., between the 22 of Dec. 1724, and 6 of October, 1728, leaving, as stated in his will, seven children--Nicholas, Walter, Thomas, Abraham, Jacob, Abigail and Catherine. To Nicholas, his eldest son, he left his Newton plantation; and to his son Walter his plantation in (Bergen Co.) "New Jersey", where Walter's descendants and those of his brother Abraham, who had moved with him, became very numerous. They affiliated themselves with the Dutch settlers, and soon their surname underwent a change in spelling, from Pearsall to Persel, Parcel and even Purcells. The plantation in Elizabeth, N. J., was left by William Parcell to his two sons, Thomas and Abraham, the latter having followed his brother Walter to Bergen County, while the descendants of Thomas, it will be seen, formed the Elizabeth Town branch of the family.

III--Thomas Persells, son of William Parcell, migrated when a young man to Staten Island, and there, 15 May 1697, recorded his emark. From Richard Salter of Freehold, an attorney for William Dockura of London, one of the East Jersey proprietors, he bought, May 22, 1702, a large tract of land near Elizabeth; and May 6, 1709, he purchased from Thomas Gordon a much larger tract. His wife's name and children's date of birth have been learned, and he is without doubt the father of Stephen Passell, mentioned below.

IV--Stephen Passels, who was born 1726. He died 8 of April, 1786 in Elizabeth Town in his sixtieth year. His wife and six children are named in his will. He married Phebe, who was the daughter of Nathaniel and Mary (Price) Crane, a granddaughter of Stephen Crane of Elizabeth Town, through his son Nathaniel, and Samsaris (Ward) Crane.

William Stiles married June 7th, 1761, Phebe, (daughter of John and Constance) Spinning, who was born 31 October, 1736 and died 22 November, 1822. He died in Elizabethtown, N. J. 24 January, 1781. The following were their children:

1st. Phebe, born 13th or 15th March, 1762, married Carey (or Caleb) Headley, born February 14, 1756 and settled in Headley Town (between Springfield and Orange) N. J. where his descendants are numerous.

2nd. William, born January, 1764 at Elizabethtown, N. J., married Abigail Passell, (In three of the descendants' bibles the name is spelled Passell, Parcell, and Purcell.)

3rd. John, born Dec. 11th or 13th, 1766, married (first) Phebe Crane, married (second) Deborah Hendricks; married (third) Hannah Higgins.

4th. Daniel, born January 28th, (February 13, 1772), 1773, married Phebe Woodruff.

And others.

William Stiles 5 (William⁴, John³, Isaac², John¹.) born at Elizabethtown, N. J. June 4, 1764, married the 1 June, 1784 Abigail Passell, born 5 January 1764, removed to a farm near Basking Ridge, N. J. where he died the 5 September, 1822. They were members of the Presbyterian Church at Basking Ridge, N. J. Their children were Phebe, Mary and others.

Issue: Phebe, born 15 February, 1785, married 14 September, 1811, John Stiles of Vernon, New Jersey.

2nd. Mary, born 30 June, 1788, married 15 December, 1807, Smith Baldwin, building contractor of Elizabethtown, N. J. She died 16 April, 1840 at Cincinnati, Ohio, whither the family had removed after Mr. Baldwin's death 27 August, 1823.

Issue:

I. Abigail Parcell Baldwin, born Dec. 16, 1808, (or Dec. 5), married William Morris Pruden Jan. 12, 1828 in Elizabethtown, had daughter Mary J.M. who married ----Barrows and resided in Freeport, Ill. She died Sept. 7, 1851 aged 19 years; and a son George M. Pruden who died Nov. 10, 1851 aged 21 years, and interred in Wesleyan Cemetery, Cincinnati, Ohio.
