Application of Soldier, Sailor, or Marine for Disability by Reason of Disease or the Infirmities of Age.

I, Thomas Caylor, do hereby apply for aid under the act of the General Assembly of Virginia, approved April 2, 1902, entitled an act to aid the citizens of Virginia who were disabled by wounds received during the war between the States while serving as soldiers, sailors, or marines of Virginia, and such as served during the said war as soldiers, sailors, or marines of Virginia, who are now disabled by disease contracted during the war, or by the infirmities of age, and the widows of soldiers, sailors, or marines of Virginia who lost their lives in said service, or whose death resulted from wounds received or disease contracted in said service, and providing penalties for violating the provisions of this act, and I do solemnly swear that I am a citizen of the State of Virginia resident at Columbian, in the County of Fairfax, in the said State, and that I have been an actual resident of the said State for two years, and of the said city (or county) for one year next preceding the date of this application, and that I was a soldier (or sailor or marine) of the State of Virginia in the war between the United States and the Confederate States, as a member of (here state specifically the command and branch of service to which the applicant belonged, and the names of his immediate superior officers) Strickling's Artillery, Pickett's Division, and that I am now disabled by disease (here state the nature of the disease and the causes from which it resulted) Paralysis of the throat, cause I do not know, and that from the effects of such disease I am now permanently disabled from following my usual and ordinary occupation or any other occupation for a livelihood (in the case of disability from the infirmities of age, strike out all relating to disability by disease, and then proceed as follows:), and that I am now suffering from the infirmities of age, and permanently incapacitated thereby from following my usual and ordinary occupation, or any other occupation, for a livelihood (here state specifically the nature and character of the disability which prevents the applicant from following any occupation for a livelihood) and that during the said war I was loyal and true to my duty, and never at any time deserted my command or voluntarily abandoned my post of duty in the said service, and that by reason of such disability I am now entitled to receive under the said act the sum of Thirty dollars annually. And I do further swear that I do not hold any national, State, city or county office which pays me in salary or fees one hundred and fifty dollars per annum; nor have I an income from any other employment or any source whatever which amounts to one hundred and fifty dollars per annum; nor do I receive from any source whatever money or other means of support in value of the sum of one hundred and fifty dollars per annum; nor do I own in my own right, nor does any one hold in trust for my benefit or use, nor does my wife own, nor does any one hold in trust for my wife, estate or property, either real, personal or mixed, either in fee or for life, of the assessed value of five hundred dollars; nor do I receive any aid or pension from any other State, or from the United States, or from any other source, and that I am not an inmate of any soldiers' home, or of any other public institution; and I do further swear that the answers given to the following questions are true:

- 1. What is your age? Ans. 65 years.
2. Where were you born? Ans. Loudoun County, Va.
3. How long have you resided in Virginia? Ans. all my life.
4. How long have you resided in the city or county of your present residence? Ans. 30 years.
5. What is your usual and ordinary occupation for earning a livelihood? Ans. Farming.
6. How long have you followed such occupation or employment? Ans. 40 years.
7. Have you followed such occupation or employment, or any other occupation or employment, within the last two years? If so, state when and where, and the amount of your annual income from the same. Ans. I have not, have not been able.

- 8. State specifically the nature of your disability or disease. Ans. Paralysis of throat.
9. What were the causes which led to the disease which has resulted in your disability? Ans. Exposure.
10. How long have you suffered from such disease, and when did you first become aware that you were afflicted with the same? Ans. April 25th 1904.
11. With what disease or sickness did you suffer during the time of your service? Ans. Severe Colds.
12. Are you totally disabled because of such disease, or the infirmities of age, from following your usual and ordinary occupation or employment, or any other occupation or employment?
13. When and where did you enter the service of Virginia, or of the Confederate States? Ans. at White's Landing.
14. In what command and service were you engaged during the war between the States? Ans. Strickling's Artillery.
15. How long were you in the service? Ans. 3 years.
16. When did you leave the service, and under what circumstances? Ans. after Surrender, I was Paroled.
17. If suffering from disease, state what physician or physicians have attended you for the same. Ans.
18. Give the names and addresses of two or more in the service of your command, if any such be living, and if not, so state. Ans. John A. Dobbins, John W. Criddle, Herndon, Fairfax Co.
19. Give here any other information you may possess relating to your service, or disability, that will support the justice of your claim for aid? Ans. My health has been impaired ever since I was in the Army.
20. Is there any camp of Confederate Veterans in the city or county of your residence? Ans. There is Camp War.
21. Is there any one living, the residence and address of whom is known to you, either comrade or otherwise, who has knowledge of your service, and of the cause of your disability? If so or not, state. Ans. There is William E. Reid, Columbian, Va.

(D) CERTIFICATE OF PHYSICIAN.

I, W. Leigh, a practicing physician in the County of Fairfax, in the State of Virginia, do certify that I am personally acquainted with Thomas Caylor, whose name is signed to the annexed application for aid under the act of the General Assembly of Virginia, approved April 2, 1902, and that from a personal examination of the said Thomas Caylor, as to the disability set forth in his application and the cause thereof, I am clearly of the opinion that he is disabled by reason of (here state specifically the nature of the disability and the cause thereof, and if such disability be total, whether the applicant is deprived thereby of all ability to pursue his usual and ordinary occupation for a livelihood, or any other occupation for a livelihood, and if the disability be partial, to what extent the applicant is hindered thereby from pursuing such occupation as aforesaid) The applicant was fractured in his back Oct. 25, 1904, and the stroke has severely affected his general health, much impaired it in my opinion he is totally disabled for manual labor, and that I verily believe his disability is wholly due to causes assigned in the said application, and that he is entitled to aid under the provisions of the said act, and that I have no personal interest in the allowance of the applicant's claim.

Rogers (Loudoun Artillery) as below the service standard, having only 45 men present for duty and only 2 Lieuts. not fully adequate to command, 1 sergeant present, the Captain himself being absent on private account. The company has served throughout the war and with effect in several actions; but it is not now in fair condition, nor does it present much promise for the future. Its men and horses I recommend for Captain Shubling's Oct 4th 1862. Special orders No 209, Sec 13, Hdqrs Army at W. Va. The officers of Captain Rogers' Battery, Loudoun Artillery, are relieved from duty with the company. The men and horses will be assigned to Captain Shubling's Battery."
