

Will - William Lafever

Loudoun County, Virginia - Will Book 2E, page 1

In the name of God Amen. I William Lafever of Loudoun County and State of Virginia being old and infirm in body but of sound disposing mind do make and ordain this writing my last will and testament in manner and form following - That is to say,

First, it is my will and desire that all my just debts and buryal expenses shall be paid out of any estate.

2nd In addition to what I have heretofore given unto my daughter Rachel Havener wife of Bassil Havener of Loudoun County and state of Virginia the sum of Fifty dollars without half the intrust that maybe due thereon the said 200 dollars of a debt of two hundred dollars owing to me from Bassil Havener to her and her heirs to have and to hold the same forever and no more.

3rd In addition to what I have heretofore given until my daughter Hannor Arundell wife of Joseph Arundell of Loudoun County and state of Virginia I do give unto her and her heirs forever Fifty dollars to be paid out of the above mentioned debt owing to me from Bassil Havener and no more.

4th In addition to what I have heretofore given my son William Lafever of Loudoun County and state of Virginia I do give unto him and his heirs forever one set of silver Table spoons and one set of silver Teaspoons having the Initials of his name engraved thereon. I do also give and remit all bonds, debts and accounts due to me from my son William Lafever and no more.

5th In addition to what I have heretofore given to my son Henry Lafever of Loudoun County and state of Virginia I do give unto him and his heirs forever fifty dollars to be paid out of the above mentioned debt owing to me from Bassill Havener. I do also give and and remit all bonds debts and accounts due to me from my son Henry Lafever and no more

6th In addition to what I have heretofore given unto my son Peter Lafever of Loudoun County and state of Virginia I do give unto him and his heirs forever fifty dollars to be paid out of the above mentioned debt owing to me from Bassil Havener. I do also give and remit all bonds debts and accounts due to me from my son Peter Lafever and no more

7th I do give unto my two sons Samuel and John Lafever both of Loudoun County and state of Virginia and to their heirs forever to be equally divided between them all the money that may be found in my possession and that may be owing to me at the time of my decease also all my Household Kitchen furniture and farming Utensils of every description whatsoever also all my Bacon corn in the House and all other grain Hay and straw that may be on my premises also all my stock of Hogs also their choice of five head of horses four head of cattle and no more the remainder of my stock to be sold and the proceeds thereof to be equally divided.

And lastly I do hereby constitute and appoint my son William Lafever Executor of this my last will and Testament hereby revoking all other or former wills and Testaments by me heretofore made.

In witness whereof I have hereunto set my hand and fixed my hand and fixed my seal this day of June 1847.

Signed sealed published and declared by William Lafever as for his last will and Testament in the presence and hearing of us who at his request and in his presence have subscribed our names as witnesses. Amos Fouch Senr, and Ellen Fouch (her mark), Robert Power

At a Court held for Loudoun County the 11th February 1850 A paper purporting to be the last will and Testament of William Lafever decd was presented to the Court proved by the oaths of Amos Fouch and Robert Power to of the subscribing witness thereto and ordered to be recorded and on the motion of William Lafever who made oath as executor and together with Joseph Arundell and Samuel Lafever his securities entered unto and acknowledged a bond in the penalty of two thousand dollars conditioned as the law directs certificate is granted the said William Lefever probtaining (?) a probate thereof in due form.
