I have the following information about Wilmoth, daughter of Joseph and Wilmoth RUDD. Although there are no absolute dates for the earlier RUDDS, dates have been estimated from marriage dates and dates that the sons of John and Avis RUDD appeared in court records. It is estimated that Joseph RUDD was born in the early 1720s (ca. 1723) which would make it impossible for him to have a daughter old enough to marry in 1741.

As you can see, records indicate that Wilmoth's husband was Henry AVERETT. Court records of Mecklenburg name Jarrott AVERETT, and others, as children of Henry AVERETT. Other records from Wilson Co., TN, show that Henry was Wilmoth's husband (see record below concerning Susannah AVERETT GLASGOW).

Joseph was a son of John and Avis WHITTAKER RUDD. John and Avis had eight

known children - all of whom can be verified by the wills and estate settlements of John and Avis:

- 1. John who married Hannah (maiden name believed to be RUSSELL)
- 2. William RUDD
- 3. Rebecca who married John FRITH (she did NOT marry a second time to a

BROWN as believed by some researchers)

4. Thomas who married (1) Margaret ROBERTSON and (2) Elizabeth _____. (He is NOT the Thomas who married Elizabeth Walker INGRAHM. That Thomas was

the son of Joseph and Wilmoth RUDD.) Thomas and Margaret ROBERTSON RUDD are

my ancestors.

in Mecklenburg Co., VA. He married WILMOTH RUDD in VA, daughter of JOSEPH

RUDD and WILMOTH UNKNOWN. She was born Abt. 1758 in VA, and died Abt. 1821 in Mecklenburg Co., VA.

Notes for WILMOTH RUDD:

She and Henry AVERETT were married by 31 January 1779 (date of her father's will). Henry was the son of Thomas (d. by 6 September 1757) and Sarah AVERETT. Joseph RUDD, Wilmoth's father was one of the appraisers of Thomas AVERETT's estate.

Henry contributed 175 cwt (?) of beef for continental use during the Revolutionary War.
